Learning Objectives

- ◆ Discuss the safety versus risk of enteral feeding for patients on pressors. Understand the vasoactive inotropic score and its use to help guide enteral feeding. Learn how ECMO affects feeding the cardiac patient and review barriers to reaching goal calories and protein and strategies for improvement.
- ◆ Identify one's own values that support ethics driven dietetics practice. Apply the 19 principles in the "Code of Ethics for the Profession of Dietetics". Explain the major steps of the process for consideration of an ethics issue and list the potential outcomes if the "Code of Ethics for the Profession of Dietetics" is determined to have been violated.
- ◆ Identify the role of a registered dietitian in the medical stabilization of eating disorders patients. Identify common nutritional complications seen in eating disorder patients. Determine utilization of enteral and parenteral nutrition in the treatment of eating disorder patients.
- ◆ Interpret potassium, phosphorus, and magnesium laboratory values in the context of a patient's clinical status. List variables that can affect these electrolytes laboratory values. Describe strategies for replacement of these electrolyte deficiencies, including when or when not to make adjustments to parenteral nutrition.
- ◆ Describe factors that influence movement of fluid and sodium between fluid compartments. Understand treatments for fluid and sodium disorders. Design appropriate nutrition care plans for patients with fluid and sodium disorders.
- ◆ Understand the disease state of short bowel syndrome. Describe therapeutic goals for patients with short bowel syndrome. Understand the role of GATTEX® and describe access and patient services for GATTEX®.
